ORDER:

In the Government Order read above, detailed instructions have been issued among others, relating to preparation of panel for appointment by promotion / recruitment by transfer, to various posts in the State and Subordinate Services.

2. As per paragraph 2 II (ii) under the heading "Preparation of Panels" in the Government Order read above, the cases of persons to be considered for inclusion in the panel should be examined by opening Sectional Notes in Proforma II given in Annexure V to the said Government Order.

3. After detailed examination, Government have decided to include certain columns relating to the pendency of criminal cases and cases in Tribunal for Disciplinary Proceedings. Accordingly, the following amendment is issued to Proforma II given in Annexure V to the Government Order read above.

AMENDMENT

In the said Government Order, in the Proforma-II in ANNEXURE V, after item 9, the following item shall be inserted, namely:-

- 9-A (a) Whether any criminal case is pending against the officer in the official capacity and if so, indicate the details thereof; nature of crime for which he is proceeded against:

- (c) Present stage of the enquiry by the Tribunal for Disciplinary Proceedings:
